


## **BILLS THAT DID NOT PASS**

- Bill Introduced to Allow 3<sup>RD</sup> Party
  Delivery of Alcohol
  - × It would have allowed Instacart, Uber Eats, etc. to deliver alcoholic beverages.
- × Bill Introduced to Allow Self-Serve Beer/Wine Dispensing Machines
  - It would have allowed beer/wine "walls", usually prepaid with an ounce limit where patrons would pick out and pour their own drink depending on how much they paid.

- Bill Introduced to Allow Off-Premises Alcohol Delivery
  - It would have allowed grocery stores, convenience stores, etc. to deliver alcoholic beverages.
- Bill Introduced to Change the Responsible Alcohol Sales and Service (RASS) Program
  - It would have required ABCD to certify two training programs. One for on-premises and one for offpremises consumption and shortening training time.


