GENERAL

Quota = Represents the number of licenses allowed to exist in that area based on population. See 16-4-201, 16-4-105, and 16-4-420 for further information.

Issued = Represents the number of licenses that are currently issued by the department in that area.

Var. = Represents the number of licenses that are available. This is determined by subtracting the 'Issued' column from the 'Quota' column. In the case of all-beverage licenses, you must first add in the 'Fltrs Issued' column prior to subtracting the 'Issued' column.

Apps Pend = Represents the number of applications that have been submitted to the department and are still pending. These applications have not been approved by the department.

ALL-BEVERAGE LICENSES

Vet/Frat Transfer = Represents the number of Veteran and Fraternal licenses that may be transferred or reassigned. These licenses were issued prior to 1949.

Fltrs Pend = Represents the number of floater applications that have been submitted to the department and are still pending. These applications have not been approved yet.

Float Out = Represents the number of licenses that may be floated out of the quota area to another quota area that allows for it. A license may be floated out when the number of licenses issued in the original quota area exceeded the quota by at least 25%. See 16-4-204 for further information.

Float In = Represents the number of licenses that may be floated into the quota area from another quota area that allows for it. A license may be floated into a new area when the number of licenses issued in the new quota area does not exceed that area's quota by more than 33%. (43% for incorporated cities of more than 10,000 inhabitants). See 16-4-204 for further information.

RBW LICENSES

101 Seating Issued = Represents the number of RBW licenses issued that are licensed for 101 or more seating capacity.

% 101 Seating Issued = Represents the percentage of 101 or more seating capacity licenses issued to the total number of RBW licenses allowed in the quotal area. This may not exceed 25%.
