

Delivery of Beer and Wine Off-Site with Food

Beer and wine in original packaging may be delivered by certain on-premises licensed alcoholic beverage establishments with food prepared by the licensee.

Licensees allowed to deliver beer and wine with food:

- Entities licensed under <u>16-4-105</u>, MCA (On-premises beer/wine licenses).
- Entities licensed under <u>16-4-201</u>, MCA (On-premises all-beverage licenses).
- Entities licensed under <u>16-4-420</u>, MCA (Restaurant beer and wine licenses).

Excludes the Following:

- Off-premises licenses
- Airport all-beverages licenses
- Golf course beer/wine licenses
- Resort (no delivery outside the resort area) licenses
- Nonprofit arts licenses
- Yellowstone airport beer/wine licenses
- Montana heritage licenses
- Continuing care retirement center licenses
- 3rd party delivery services

Requirements:

- Licensee must apply and get approval for an alcohol delivery endorsement.
- Delivery may only occur by the licensee or licensee's employees who are:
 - 21 years of age or older and server trained. Licensees may not use 3rd party delivery services to deliver alcohol (such as Uber Eats, Grubhub, Door Dash, etc.).
- Beer and wine must be in original packaging. Liquor delivery is not allowed.
- The delivery must include food prepared by the licensee.
- The purchase price of the delivered beer and wine may not exceed the purchase price of the delivered food items.
- Licensee must verify purchaser is 21 years of age or older and not intoxicated.

The process to get approval for a delivery endorsement:

- You may only apply online through TAP:
 - Log into your TAP account.
 - o Select the on-premises license you want to add the delivery endorsement to.
 - Select "More" on the right.
 - Select in Account Options "Request Changes to Account".
 - o Check "Add/Remove Alcohol Delivery Endorsement"
 - Follow the prompts for information and payment.
- Do not begin delivering alcohol until the department approval has been granted and the new license has been printed indicating approval to do so.
