Form 1099-G Will No Longer Be Mailed

The Montana Department of Revenue will no longer mail copies of Form 1099-G. These forms show your income tax refunds, credits, interest, or offsets from the Montana Department of Revenue and may be required when filing your federal income tax return.

Taxpayers can view their Form 1099-G in the department's [TransAction Portal \(TAP\)](#) by going to [Get1099.mt.gov](#).

We've redesigned Montana Form 2

We've made changes to our [Individual Income Tax Return \(Form 2\)](#) to streamline our process and comply with changes to the federal Form 1040.

We have also eliminated the Montana Form 2EZ (Short Form). Taxpayers who have filed Form 2EZ in the past may be able to file their return using only the first page of the Form 2.

The Montana Elderly Homeowner/Renter Credit is no longer available on paper for individuals without a filing requirement, however they can claim the credit using our TransAction Portal (TAP).

Taxpayers may claim the Homeowner/Renter Credit by completing pages 1 and 9 on the new Form 2 if they have a filing requirement or would rather file using a paper form.
